

AUTHORIZATION AGREEMENT

If funds are erroneously deposited to the undersigned's bank account, I authorize Company to direct my bank to return any deposited funds to which I was not entitled by adjusting my bank account as appropriate. If any Day of Debit is not a business day, the debit authorized by this Authorization Agreement will occur on the next following business day. I hereby acknowledge that the origination of ACH transactions to my Account must comply with the provisions of U.S. law.
